Sr. No.	Category	Entry fees per Participating Unit Rs.
1.	Companies with Total Annual turnover up to Rs. 25 crores	10,000/-
2.	Companies with Total Annual turnover between Rs. 25 – 100 crores	20,000/-
3.	Companies with Total Annual turnover above Rs.100 crores	30,000/-

SELECTION:

The panel of experts will consist of a number of selected individuals with a vast hand on knowledge and experience in **Plant, Production and Quality & Regulatory Affairs** will visit the participating units between **1st October 2015 to 15th December 2015**. Their interaction with your executives is crucial! The Panelists will make recommendations and suggest ways to enhance safety and productivity.
