Dear Sir,

This is in continuation of our clarification vide letter dated 8th April, 2022 on the above subject.

We would like to clarify that we have since our incorporation followed an ethical code of conduct and have considerably invested in imparting ethical training to our marketing executives during their induction as well as routinely, to build a robust, strong and an ethical marketing team. We instill values of safety, equality, honesty, responsibility, respect, compassion, gratitude and adaptability amongst our employees. We foster diversity and ensure a free, safe, healthy and a violence free work environment. In all our training programmes including induction and regular training batches we extensively cover the values and Code of Ethics session where we extensively emphasize on Alkem's ethical Values and the Code of Conduct. Through continuous effort, we have created significant goodwill and reputation in the market. One of the presentation on Code of Ethics is enclosed herewith as '**Annexure A**'.

As indicated in our earlier letter of 8th April, 2022, we also have a robust Whistleblower Policy in place to look into any complaints and/or any unethical practices that are brought to our attention. The said Policy is also displayed on the official website of our Company. The purpose of the said Policy is to enable our employees and/or others to report any action or suspected action that is illegal, fraudulent and is in violation of any adopted policy of our Company and to build and strengthen a culture of transparency and trust within the organization.

In the event, an individual reasonably believes that a violation has occurred, the individual is encouraged to share his/her complaints to a person designated by our Company. In addition to the same, under exceptional circumstances where a complainant wants to complain directly to the Chairman of the Audit Committee he/she is entitled to do so.

Thereafter, all reported violations are promptly investigated for causing appropriate corrective action to be taken if warranted by the investigation.

Further, our Annual Report also mentions the number of whistleblower complaints received, the nature of the complaints and the number of complaints that are resolved and/or remain pending. We also mention about our Whistleblower Policy in our Corporate Governance Report and our Boards Report, which in turn forms part of our Annual Report.

We would like to humbly submit that the allegations made in the present Complaint are vague, evasive, non-specific and are based on conjectures and surmises. We would also like to bring to your attention that the said Complaint is also devoid of any material particulars and has been made without any proof to substantiate the allegations mentioned therein. We would also like to state that it appears that the Complaint has been initiated with an objective to malign our reputation and goodwill and should be dismissed.

In view of the aforementioned, we request you to kindly present these facts to the Department of Pharmaceuticals, Ministry of Chemicals and Fertilizers accordingly.



KNOW YOUR RESPONSIBILITY

- Use good judgement to ensure that personal use of company owned devices & network does not interfere with our work environment in anyway




